NON-COMPLIANCE FEE

- Every document filed for recordation shall be captioned as to the type of act on the first page. The first page should have a margin of two (2) inches at the top and one (1) inch at the bottom and sides. The type on each document shall not be less than eight (8) point.
 - Non Compliance \$10.00
- A final judgment for the payment of money and lien having the effect of a money judgment should have the last four digits of the social security number of each debtor or the IRS number of the business
 - Non Compliance per debtor \$25.00
