COME BACK TO THE PRECINCT REGISTER FOR EACH OF THE VOTERS BELOW:

SCENARIO 1: DECLARATION REQUIRED

KRIS SAVOIE WILL BE VOTER 1 (WILL SELECT REPUBLICAN)
WE MUST GET THE COMMISSIONERS TO UNDERSTAND THAT WE STOP! WHEN THERE IS DECLARATION REQUIRED IN THE SIGNATURE LINE (SIGNS WILL COME IN HANDY HERE)

1. CHECK THE PRECINCT REGISTER TO LOCATE THE VOTER
2. NO PARTY VOTER CAN DECLARE R OR D
3. THEY CAN ALSO CHOOSE TO NOT DECLARE AND VOTE ON OTHER BALLOT MEASURES (UNAFFILIATED)
4. IF THERE IS NO U NUMBER FOR THE VOTER IN THE PRECINCT REGISTER, THERE ARE NO BALLOT MEASURES THAT THE VOTER CAN VOTE ON
5. GIVE CORRECT LOCKOUT CARD BASED ON DECLARATION
6. IF VOTER GETS AGITATED, PLEASE CALL THE OFFICE AND/OR THE ROV

MATERIALS NEEDED:

1. KRIS SAVOIE ID
2. DECLARATION FORM

SCENARIO 2: DECLARATION REQUIRED + VOTER ASSISTANCE REQUEST

AGAIN, WE WILL STOP TO ASSESS THE SITUATION

ALICIA RENEE ADAMS IS VOTER 2 AND WILL ASK FOR ASSISTANCE IN THE VOTING BOOTH.

ASSISTANT ANNIE WILL BE PRESENT WITH HER ID AS WELL

MATERIALS NEEDED:

1. ALICIA ADAMS ID
2. ASSISTANT ANNIE ID
3. ASSISTANCE TO VOTERS FORM
4. DECLARATION FORM

THE ASSISTANT MUST FILL OUT THE ASSISTANCE TO VOTERS PAGE BEFORE ANY VOTING CAN TAKE PLACE.

THE ASSISTANT WILL FILL OUT THE MIDDLE PART OF THE FORM AND MUST INDICATE BY CHECKING THE BOX IF THEY ARE PAID TO PROVIDE ASSISTANCE.

THE ASSISTANT CAN NOW HELP THE VOTER WITH THE DECLARATION PAGE

REMEMBER, THE FOLLOWING PEOPLE **CANNOT** PROVIDE ASSISTANCE TO A VOTER:

1. THE COMMISSIONER IN CHARGE
2. A CANDIDATE ON THE BALLOT
3. THE VOTER'S EMPLOYER
4. A UNION REPRESENTATIVE

ANYONE ELSE IS ELIGIBLE

REMINDER: AN ASSISTANCE TO VOTER FORM MUST BE FILLED OUT FOR EVERY ELECTION REGARDLESS IF THERE IS A Y IN THE ASSISTANCE COLUMN OR NOT.

THE COMPLETED FORM GOES INTO THE ROV ENVELOPE.

SCENARIO 3: ADDRESS CONFIRMATION REQUIRED + DECLARATION

(NOTE: THE ACC IN THE FUTURE WILL BE CALLED ADDRESS CONFIRMATION FORM)

JOANN GILFOUR IS THE VOTER. SHE WILL NEED TO BE GIVEN THE ADDRESS CONFIRMATION FORM AND THE DECLARATION FORM

1. HAS DECLARATION AND ADDRESS CONFIRMATION REQ.
2. DO NOT HAVE THE VOTER SIGN THE PRECINCT REGISTER
3. DO NOT HAVE THE POLL BOOK WRITERS WRITE ANYTHING
4. ACC AND DEC. PAGE MUST BE GIVEN TO THE VOTER
5. COMMISSIONER MUST FILL OUT TOP PART OF ACC BEFORE GIVING TO VOTER
6. COMMISSIONER MUST CHECK ACC FORM FIRST
 - A. VOTER FILLS OUT PARTS 2 AND 3: THE FOLLOWING MAY OCCUR
 - B. VOTER CONFIRMS ADDRESS (MAY OR MAY NOT ADD A PO BOX) THEY CAN VOTE ON A MACHINE
 - C. VOTER AFFIRMS THEY STILL LIVE IN THE PARISH, BUT THEY ARE AT A NEW ADDRESS. THEY CAN VOTE IF THEY AFFIRM THEIR NEW RESIDENTIAL ADDRESS. THEY CAN ADD A PO BOX HERE AS WELL. THEY CAN VOTE ON A MACHINE.
 - D. IF THE VOTER HAS MOVED OUT OF PARISH BUT SAYS THAT THE MOVE WAS LESS THAN 90 DAYS AGO. THEY CAN STILL VOTE ON A MACHINE. GIVE THEM A NEW VOTER REGISTRATION FORM TO FILL OUT. THEY CAN VOTE ON A MACHINE
 - i. IN THE UNLIKELY EVENT THAT THE VOTER SAYS THEY MOVED OUT OF PARISH MORE THAN 90 DAYS AGO, THE COMMISSIONER SHOULD CALL THE ROV OFFICE TO INFORM THEM THAT THE VOTER HAS MOVED OUT OF THE PARISH. THE ROV WILL MOST LIKELY TELL THEM THAT THEY CANNOT VOTE ON MACHINE BUT CAN ON A PROVISIONAL.
7. CHECK THE DECLARATION PAGE
 - a. CHECK THE PRECINCT REGISTER TO LOCATE THE VOTER'S PARTY AFFILIATION
 - i. VOTER SELECTS DEMOCRAT
 - b. NO PARTY VOTER CAN DECLARE REPUBLICAN OR DEMOCRAT
 - c. THEY CAN ALSO CHOOSE TO NOT DECLARE AND VOTE ON OTHER BALLOT MEASURES (UNAFFILIATED)
 - d. IF THERE IS NO U NUMBER FOR THE VOTER IN THE PRECINCT REGISTER, THERE ARE NO BALLOT MEASURES THAT THE VOTER CAN VOTE ON

e. GIVE CORRECT LOCKOUT CARD BASED ON DECLARATION

f. IF VOTER GETS AGITATED, PLEASE CALL THE OFFICE AND/OR THE ROV

SCENARIO 4: NO ID + DECLARATION

MARK LEDET WILL BE THE VOTER AND HE DOES NOT HAVE HIS ID WITH HIM AND HE CANNOT RETURN HOME AND BACK TO THE POLLS WITH HIS ID BEFORE THE END OF ELECTION DAY. HE ALSO HAS DECLARATION REQUIRED IN HIS SIGNATURE LINE. MARK WILL DECLARE UNAFFILIATED

1. VOTER IDENTIFICATION AFFIDAVIT
2. NEVER TELL SOMEONE THAT THEY CANNOT VOTE

MATERIALS NEEDED:

1. VOTER IDENTIFICATION AFFIDAVIT
2. DECLARATION FORM

SCENARIO 5: ADDRESS CONFIRMATION REQUIRED: MOVED WITHIN LAST THREE MONTHS.

NICOLE GRANIER IS THE VOTER

ADDRESS CONFIRMATION REQUIRED APPEARS IN THE SIGNATURE LINE OF THE PRECINCT REGISTER (NOTE: THE ACC IN THE FUTURE WILL BE CALLED ADDRESS CONFIRMATION FORM)

1. GET THE PINK ADDRESS CONFIRMATION SHEET
2. COMMISSIONER FILLS OUT SECTION 1 USING THE PRECINCT REGISTER
3. VOTER FILLS OUT PARTS 2 AND 3: THE FOLLOWING MAY OCCUR
4. VOTER CONFIRMS ADDRESS (MAY OR MAY NOT ADD A PO BOX) THEY CAN VOTE ON A MACHINE
5. VOTER AFFIRMS THEY STILL LIVE IN THE PARISH, BUT THEY ARE AT A NEW ADDRESS. THEY CAN VOTE IF THEY AFFIRM THEIR NEW RESIDENTIAL ADDRESS. THEY CAN ADD A PO BOX HERE AS WELL. THEY CAN VOTE ON A MACHINE.
6. **THE VOTER AFFIRMS THAT THE ADDRESS IN THE PRECINCT REGISTER IS INCORRECT BUT THE ONE ON HER ID IS CORRECT AND STILL WITHIN THE PARISH.**
7. IF THEY MOVED OUT OF PARISH MORE THAN 90 DAYS AGO, CALL THE REGISTRAR TO HAVE THEM EXPLAIN THEIR OPTIONS TO THE VOTER. DO NOT TELL A

VOTER THAT THEY CANNOT VOTE. THEY MAY BE GIVEN A PROVISIONAL BALLOT OR TOLD TO GO TO ANOTHER PARISH. THIS IS A HIGHLY UNLIKELY SITUATION.

SCENARIO 6: PROVISIONAL VOTING: VINNY VOTER (ALWAYS CALL THE CLERK OF COURT ELECTION DEPARTMENT BEFORE YOU ISSUE A PROVISIONAL BALLOT. WE WILL TALK YOU THROUGH IT.)

1. PROVISIONAL BALLOTS AND DECLARATION (VOTER WILL TELL THE COMMISSIONERS THAT THEY CANNOT MAKE IT TO THEIR POLLING LOCATION AND INSIST ON VOTING IN THE CLOSED PRIMARY) IN THIS SCENARIO THE VOTER (NAME: VINNY VOTER) WILL BE A NO PARTY VOTER AND WRITE "NO PARTY" ON THE FLAP: AND WILL USE THE DECLARATION PAGE TO VOTE "REPUBLICAN"

i. FIRST LOOK IN THE PRECINCT REGISTER FOR THE VOTER

ii. IF THEY ARE NOT A VOTER IN THE PARISH (WHICH YOU WILL DETERMINE BY CONSULTING GEAUXVOTE OR THE ROV) YOU CAN OFFER A PROVISIONAL BALLOT

iii. HAVE THE VOTER FILL OUT SECTION 2 OF THE PROVISIONAL ENVELOPE

iv. NOTE THE RESPONSE IN POLITICAL PARTY AFFILIATION

1. REPUBLICAN OR DEMOCRATS WILL NOT FILL OUT A DECLARATION PAGE

2. A NO PARTY VOTER WILL HAVE TO FILL OUT A DECLARATION PAGE OTHERWISE THEY CANNOT FILL OUT A PROVISIONAL BALLOT

3. THEN COMPLETE SECTION 1 AND THE TOP REMOVABLE FLAP IN RED WITH THE BALLOT TRACKING NUMBER THAT IS ON THE TOP OF THE BALLOT

4. THE COMMISSIONER MUST PRINT THE VOTER'S NAME IN THE PROVISIONAL VOTERS TAB (BACK OF PRECINCT REGISTER); THEN THE VOTER SIGNS THEIR NAME AND PRINTS THEIR ADDRESS, THE COMMISSIONER INITIALS NEXT TO THE SIGNATURE, THE POLL BOOK WRITERS NOTATE THE VOTER ON THE PROVISIONAL VOTERS PAGE (29) IN THEIR BOOKS

5. UNDER NO CIRCUMSTANCES SHOULD THE VOTER VOTE ON A MACHINE

6. ALL VOTED, SPOILED AND UNUSED BALLOTS WILL GO INTO THE PROVISIONAL ENVELOPE WHICH WILL BE PUT INTO THE CLEAR CLERK BAG

BONUS SCENARIO 1: DECLARATION REQUIRED

KATE SPADE IS THE VOTER

MATERIALS NEEDED:

VOTER WILL NEED TO MAKE A DECLARATION. THIS ONE WILL BE MORE PRACTICE WITH AN UNAFFILIATED VOTER.

BONUS SCENARIO 2: ADDRESS CONFIRMATION REQUIRED + DECLARATION REQUIRED

STORMY SMITH IS THE VOTER

MATERIALS NEEDED:

1. STORMY SMITH ID
2. ADDRESS CONFIRMATION FORM
3. DECLARATION FORM

THE VOTER WILL AFFIRM THEIR ADDRESS BUT WILL ADD A P.O. BOX FOR MAIL AND WILL DECLARE AS A REPUBLICAN
